5. Items for Information

i) <u>Strategic Planning Update</u>

The Chief Librarian spoke to the update. Strategic Planning Committee met on March 1 and discussed the need to engage with people who don't use the library, particularly those who speak languages other than English. Staff are currently engaging in background research to inform the board about trends at BPL, in Burnaby, and in the broader library community. The Director Public Service will compile this research into a report to be shared with the Library Board. A consultant has been approached to facilitate board workshop(s) in late summer/early fall.

ii) Provincial Funding

The Chief Librarian shared news about one-time provincial funding for public libraries, in the amount of \$45 million to be spent over 3 years. Details of the amount for BPL are not yet known. The Chief Librarian thanked current and past trustees for their advocacy work in this matter, in meeting with MLAs, speaking to the Select Standing Committee on Finance, and in approving Endowment Fund spending of \$20,000 to contribute to the Association of BC Public Library Directors' Strategic Initiatives Fund.
