#### 5. Report of the Chief Librarian

## i) Strategic Plan Report: Third Quarter 2020

The Chief Librarian spoke to the report, acknowledging the creativity, resiliency and adaptability of staff in serving patrons while maintaining safety measures.

The Chief Librarian noted the following highlights:

- As part of the project to complete a digital literacy strategy for BPL, a survey asking for community feedback received 307 responses.
- Since the report, architects from Faulkner Browns provided renderings of the Metrotown Branch with bold design concepts for its public spaces. The Chief Librarian is inviting staff input before providing feedback to the architects.
- More than 170 staff participated in Gender Diversity training from TransFocus
  Consulting. The training received great feedback from staff, and the Chief
  Librarian thanked the members of the Transgender Inclusion Working Group. A
  recorded version of the training will also be made available.
- Many comments were received from patrons regarding the importance of the library during the pandemic.

# ii) COVID-19 and Library Operations

The Chief Librarian spoke to the report, highlighting the following:

- The 72-hour quarantine period for returned items was eliminated, following guidelines from provincial health authorities.
- With the introduction of a face mask policy for city facilities, a supply of face masks are now available for patrons who have not brought one with them.
- Two more staff have been recalled.
