3. Reports

i) Board Chair

The Board Chair reported on the Library's 2020 Annual Report presentation to City

<u>ACTION</u>

Council. The Board Chair expressed his gratitude to the Chief Librarian, Trustees, and staff for their hard work and achievements over the course of 2020.

ii) Council Liaison

The Council Liaison reported on the special meeting held earlier today to swear in the two newest members of City Council.

4. Items for Decision

i) Anti-Racism Climate Audit

The Chief Librarian spoke to the report, noting that every staff member will be provided with a print copy of the Anti-Racism Climate Audit and given the opportunity to read it.

The Chief Librarian spoke to the recommendation of closing the library to maximize the number of staff who can attend a facilitated session in order to prioritize actions arising from the audit.

The Chief Librarian noted that although there will be some immediate action items, this work will be ongoing.

ii) Library Opening Hours

The Chief Librarian noted an error in the report – the Library is currently open to 5:00 pm on Fridays, not 6:00 pm as indicated.

The Chief Librarian asked for Board guidance for staff to determine regular hours once the province enters Step 4 of the restart plan. The Board discussed the considerations listed in the report and recommended that staff allow for flexibility in opening hours in order to respond to changing demand.

5. Items for Information

i) <u>City Support for Community Anti-Racism Initiatives</u>

The Chief Librarian spoke to the report. Trustee Bartnik suggested that the Library's anti-racism activities be reported to the Social Planning Committee. The Chief Librarian agreed to follow up, noting that she had already shared the Anti-Racism Climate Audit with City Management.

ii) Burnaby Festival of Learning

The Chief Librarian reported on the Festival and the innovative ways that organizers found to provide virtual events, including new offerings such as pre-festival events and community stories.

iii) Strategic Plan Report: Second Quarter 2021

The Chief Librarian reported on the following highlights:

- A Community Librarian was able to livestream playoff hockey games at the food hub, greatly improving relations with a community that the Library has been trying to connect with.
- Birding Backpacks part of the Curiosity Collection are proving very popular.
- Providing lendable Wi-Fi hotspots to those who need them continues to be a priority.
- Storytimes for newcomer families through MOSAIC's Family Centre have been very successful, helped by the diversity of BIPOC representation in BPL's collection.
- Librarians completed a 12-week in-house Community Development Institute that provided them with a grounding in community work through an equity, diversity and inclusion lens.

6. Other Business

i) In-Person Library Board Meetings

The Board Chair asked Trustees about the potential for holding an in-person meeting in the fall. It was agreed to see how the next step in the restart plan goes, but there was general consensus that an in-person meeting prior to year end would be welcome.
