3. Reports

i) Board Chair

i) Strategic Planning Process

She spoke to the recommendation that the Board delay the next round of strategic planning in order to allow for more meaningful engagement with both staff and the community – at a time when impacts of the pandemic and resulting service needs can be more fully explored.
